## PRIVACY POLICY

-the procedure to gather and handle personal data is clear and transparent and used only for the services rendered by the firm;

-the user acknowledges and accepts that he/she may use the communication channel ([contato@mallet.adv.br](mailto:contato@mallet.adv.br)) to ask why his/her personal information is being used, to clarify further questions, send complains and/or suggestions, and they always have to be identifiable.

-the user acknowledges and accepts that he/she may use the communication channel ([contato@mallet.adv.br](mailto:contato@mallet.adv.br)) to ask for a copy of his/her stored personal data if he/she desires to or if required by the applicable law.
